Prior to COVID-19, we served more than 1,500 at-risk youth, reaching an average of 500 children daily. 67% of our club members came from single parent homes, and 13% of our Club members that attended our flagship O.C. Carmichael Jr. Youth Center (O.C.) are homeless. When COVID-19 hit, we pivoted to focus on a short-term mission: to be a vital community resource providing basic support for families in need, including supplemental learning, childcare, food, physical activity, and social and emotional learning and support. Through the pandemic, we served nearly 1,300 youth and facilitated over 100,429 hours of eLearning in 2020-2021 academic school year.
